Terms and Conditions

PRICES:

The corresponding price list applies from its effective date and all prior corresponding price lists are cancelled. Prices are subject to change without notice. Prices in effect at time of shipment will apply. Items may be discontinued without notice.

PAYMENT:

Net 30 days from date of shipment and past due thereafter. Settlement of past due invoices is required before additional shipments will be made. Please mall remittances to Liberty Hardware Manufacturing Corporation[®], 140 Business Park Drive, Winston-Salem, NC 27107

FREIGHT TERMS:

Shipment will be made by common carrier and freight will be charged except as follows: Freight will be prepaid on U.S. mainland shipments of 500 pcs. or \$1,500. Items in the price list may be combined for freight allowance purposes. Small shipments are sent by surface carrier unless customer specifies next day or 2nd day air. These freight charges, including insurance, will be added to invoice. There will be no additional freight charge on back orders if the original order met prepaid freight requirements:

ACCEPTANCE OF ORDERS:

Orders are accepted subject to strikes, fires or other conditions beyond our control. Acceptance of orders is subject to factory approval, including orders given to our representatives. Orders for future delivery will be billed at the prices in effect at time of shipment, unless written factory acceptance is received. No C.O.D. orders will be accepted: cash in advance would be required when open account is not approved. Orders for modified or specially fabricated items must be in writing and accepted on a non-cancelable and non-returnable basis.

MINIMUM ORDERS:

Orders under \$200.00 net will be subject to a service charge of \$15.00 net, plus freight.

NEW CUSTOMERS:

New accounts being opened must be accompanied by an order. If the value of the first order is below \$1000, it must include cash in advance. Orders with a value over \$1000 will be accepted based on credit being approved. No new order for a new account with a value under \$500 will be accepted.

YEARLY MINIMUM PURCHASES:

Accounts with yearly net purchases under \$2000 in a calendar year will be removed from our account base and directed to distributors for future purchases.

MERCHANDISE RETURNS:

CLAIMS:

Claims must be reported in writing within 10 days of receipt of goods. Shipments are packed in approved containers and our responsibility for damage in transit ceases upon acceptance by carrier. If merchandise is damaged or lost in transit, claims should be filled with delivering carrier. Claims for shortage must be made in writing with documentation and are subject to factory verification.
